METAXCHANGE.AI Strengthens Asia-Pacific Presence with Strategic Acquisition of ASIAJUTA MARKETING SDN BHD

FORT LAUDERDALE, FL – October 8, 2025 – METAXCHANGE.AI, INC., a Florida, USA "C" Corporation and owner of the Al-powered Digital Media Hub, today announced the strategic acquisition of an **81% ownership stake** in **ASIAJUTA MARKETING SDN BHD**, a Malaysian-based company specializing in the marketing and distribution of consumables across the Asia-Pacific Region. The acquisition was carried out through a mutually approved consideration.

The definitive agreement, executed on September 8, 2025, saw METAXCHANGE.Al acquire **850,500 Shares** of ASIAJUTA MARKETING SDN BHD, representing 81% of the total 1,050,000 outstanding shares. As consideration, METAXCHANGE.Al will issue **3,191,845 Common Shares** priced at **\$10.00 USD per share** on the NASDAQ Private Market. The transaction is structured as a share exchange, with the acquired company retaining 19% **ownership**, equivalent to 199,500 shares.

This acquisition is a key component of the Parent Company's strategy to provide an Alpowered Digital Media Hub, which offers virtual secure clean rooms and Al/Digital Media Hub services with ERP globally. By acquiring a majority stake in ASIAJUTA MARKETING, METAXCHANGE.Al immediately gains a significant foothold for expansion into the highgrowth **Asia-Pacific** region, integrating the marketing and distribution expertise of the Malaysian company with its advanced digital media solutions.

"Integrating ASIAJUTA's robust distribution channels and regional marketing expertise is a massive win for our global expansion strategy," said **Ahmad Moradi, Chairman and CEO of METAXCHANGE.AI, INC.** "This move is not just about expanding our market share in addition to our Grand San Miguel Marketing subsidiary; it's about providing brands and consumers in the Asia-Pacific a cutting-edge, Al-driven Digital Media Hub for unparalleled engagement and marketing effectiveness. This tax-free share exchange underscores the long-term value we see in this synergistic partnership."

The agreement includes provisions for the Parent Company to take on financial matters oversight of the Subsidiary and includes a **three-year Non-Competition Period** for the Subsidiary within the Asia-Pacific region following the Closing Date.
